Penn & Tylers Green Sports and Social Club is a non-profit organisation operating to support members of the Football Club and the local community. It is the aim of Penn & Tylers Green Sports and Social Club to provide an enjoyable environment to enhance sporting and social activities. To that end we have put together some simple "Terms of Membership" which we hope will ensure all members and their guests are able to enjoy The Club safely and without being inconvenienced. Membership cards will be issued which can also be loaded with credit for payment at the club. Your privacy is important to us. To better protect your privacy, we provide at the end of the "Terms of Membership" an explanation how and what for we process information we collect on this form. Membership attracts a discount on alcoholic beverages.

Access

- Members must present their membership card each time they visit The Club upon request from club staff or club officials. The club reserves the right to refuse entry without presentation of a valid membership card. Further proof of identity may be requested.
- Entry will be refused to anybody under the influence of drugs.
- Appropriate clothing and footwear must be worn in The Club.
- No animals are permitted in the club with the exception of guide dogs or dogs on a leash.
- The Club will open at various times during the week and weekend. Please check with The Club for specific opening times. The Club reserves the right to close facilities without prior notice should the need arise. The clubhouse and or patio (or parts thereof) may be reserved for private functions from time to time. Whenever possible advanced warning will be given.
- The Club reserves the right to terminate membership without giving reason.

Guests

- Members may be accompanied by a maximum of three guests at any one visit, unless prior arrangements have been made with the club.
- All guests must be signed in by a member.
- Only members are permitted to sign in guests.
- Players, Officials and Supporters of opposing teams of any of the sport teams visiting the facilities for matches are termed "guests" for the duration of their visit.
- Members must accept responsibility for their guests and ensure that they abide by the terms of membership.
- The Club reserves the right to refuse admission.

Health & Safety

- All members and guests should behave in a manner that is courteous and considerate to other members and guests at all times.
- All members and guests should comply with reasonable requests from club staff and officials.
- Members and guests must be over the age of 18 to purchase of alcoholic beverages. The club may seek proof of identity and reserves the right to refuse service.
- Adults are responsible for the supervision of their children whilst on the club premises (which includes the sports fields) at all times.
- No sports or games, except those provided by the Club, should be played in the clubhouse or on the patio.
- Glasses and other breakables must not be taken beyond the clubhouse or on the patio.
- Access to the clubhouse and patio should remain unobstructed.
- Cricket-, football boots and muddy footwear must not be worn in the clubhouse.
- All litter and waste should be disposed of in the bins provided.
- Smoking (including e-cigarettes) are not permitted anywhere in the clubhouse. External smoking areas are provided.

Administration

- The Club reserves the right to reject any application for membership without giving a reason.
- The fees and tariffs shall be determined by The Club and may be altered at any time. Members will be notified accordingly.
- The club reserves the right to terminate the membership of any member without notice in the event of a member committing a serious breach of The Club's terms of membership.
- On cancellation of membership no refund will be made.
- All members who wish to cancel their membership must do so in writing.
- Membership cards are only for use by the named member(s) and are not transferable.
- Replacement membership cards will be issued at a cost of £5.00.

Other Terms

- Property, including vehicles, are brought to the club's premises at the owner's risk and The Club will not accept any liability for loss and damage. The Club reserves the right to dispose on any lost items not claimed within four weeks.
- The Club reserves the right to amend these terms at its absolute discretion. Notification will be displayed on the notice board in the clubhouse.

Data Protection

- Information we do collect: Name, Address, Date of Birth, Sex, Phone Number, E-Mail Address (it is the responsibility of members to keep The Club informed of any changes).
- Information we do not collect: Financial information (including debit/credit card information), Gender ID, Race, Religion, Sexual Orientation, Medical Information.
- We use this information for processing our membership records. Only authorised members of Penn & Tylers Green Sports and Social Club have access to this information, which is curtailed to allow access only to information that is pertinent to the individual's role within The Club. The Club will not share your data with any other parties without your permission. The Club may contact you from time to time to inform you of its events or special offers that may be of interest. You may opt out of receiving these communications at any time by contacting The Club.

Our commitment to data security includes appropriate physical, electronic and procedural measures put in place to prevent unauthorized access, to maintain data accuracy and to ensure correct use of information in order to safeguard and secure the information we collect. You can access all your personally identifiable information that we collect and maintain by contacting The Club. You can correct factual errors in your personally identifiable information by sending us a request that credibly shows error. To protect your privacy and security, we will take reasonable steps to verify your identity before granting access or making corrections.
